The IWK Emergency Department treats approximately 23 injured children a day, with fluctuations between as low as 10 to as high as 40. The total number of injuries in 2024 were 8500, and approximately 3% of injury cases are admitted.

It is clear that although we have made many strides in injury prevention, there is still work to be done.

Fall Prevention

Fall Prevention Month

Theme: Baby Gates: The First Step to a Safer Home

This year's Fall Prevention Month (Nov 2024) highlighted the role of baby gates in preventing fall-related injuries in young children at home. The theme aligned with CSL's provincial Baby Gate Grant program and the pilot testing of the Safety at Home: Child Fall Prevention Toolkit, which focuses on the safe use of baby gates (see below). A new resource was developed called the Do's & Don'ts of Baby Gates. This infographic was translated into five languages to ensure broader accessibility (English, French, Mi'kmaq, Arabic, Spanish) and distributed across Atlantic Canada. Throughout the month, CSL also conducted a social media campaign with different messaging each week.



Baby Gate Grant Program

Through the generous support from the NS Department of Communities, Culture, Heritage and Tourism, CSL established a Baby Gate grant program in Nova Scotia. This two-year grant aims to improve home safety by increasing access to baby gates and related tools. Grants were available up to \$1000. The grants were provided to service providers including First Nation Health Centres/Early Learning centres, Newcomer agencies, and Family Resource Centres. A presurvey was also sent to all successful applicants to gain additional information specific to CSL and fall prevention to support the development of the Toolkit (see page 8).

Fall Prevention

Fall Prevention Toolkit

CSL developed a Fall Prevention toolkit to support fall prevention education delivered by service providers such as Family Resources Centres, Newcomer agencies, First Nation Health Centres, etc. Prior to development, a pre-survey was conducted with responses from 42 centres analyzing organizational awareness, challenges, and needs regarding fall prevention. The survey was available in English and French and was sent to Family Resource Centres, Newcomer agencies, the CSL Community of Practice, and First Nation communities.

Presurvey highlights (42 respondents)

- 94.9% indicated they were aware of CSL.
- 78.9% stated they were members of the CSL Community of Practice.
- 89.5% indicated that they were aware that CSL resources were offered in different languages.
- Almost three-quarters of the survey respondents stated that a Fall Prevention Toolkit would be helpful.
- 76.5% recommended access to free or subsidized gates.

The tool kit was drafted with support from the Atlantic Children's Fall Prevention Working Group and then piloted across Nova Scotia with 9 service providers. The Toolkit includes a fall prevention backgrounder, printable resources, "Safety at Home" PowerPoint presentation and two video resources on installing baby gates (hardware-mounted and pressure-mounted). Overall, the Safety-At-Home: Child Fall Prevention Toolkit was shared with approximately 113 families. The feedback from the pilot testing will support the revision of the toolkit that will be finalized in fiscal 2025-2026. A huge thank you to everyone who provided feedback.

Challenges Families Face in Preventing Serious Falls

Of those who answered the pre-survey question regarding the challenges families face in preventing children's falls:

- Half of them indicated that the cost of safety items, income or budgetary constraints for families would be challenging.
- Half of the survey respondents shared that access to education, credible information, and certified safety products was also challenging for families.





Poisoning Prevention

Poison Prevention Week

Theme: Prevent Poisonings Before They Happen

CSL partnered with the Atlantic Canada Poison Centre to celebrate Poison Prevention Week (PPW) from March 16-22, 2025, with many promotional activities including:



 Distributing safe storage equipment (lock bags and cabinet locks) and a new poison prevention fact sheet across Atlantic Canada.

- Illuminating key buildings in two provinces (6 buildings).
 - NS: Big Fiddle (Sydney); Colchester East Hants Public Library (Truro).
 - NB: 4 locations in Moncton: Moncton Avenir Centre, Downing Place, Downing Street, & City Hall.
- Conducting an Ipsos survey in Nova Scotia (see page 10)
- Implementing a Fact or Fiction social media campaign.
- Conducted traditional media.





PPW was also officially proclaimed in Nova Scotia by the Honourable Tim Houston and in PEI by the Honourable Mark McLane.

Safety Equipment

CSL provided safety equipment (lock bags and cabinet locks) to service providers to order (free of charge) to support programming in centres helping young families. During PPW, 710 lock bags were distributed (PEI: 15, NL 59, NS 636) and 1128 cabinet locks (NS only). CSL also received 1000 tote bags and 5000 magnets from Parachute to send to service providers across Atlantic Canada.


Poisoning Prevention

Storage Survey

CSL wanted to understand how parents in Nova Scotia store various household products, with a particular focus on cannabis edibles. An Ipsos survey (n=153) was conducted to gather insights from caregivers of children under 14 years old to assess their awareness and behaviours related to the safe storage of potentially harmful substances.

The primary goal was to determine current storage practices, awareness of poisoning prevention resources, and knowledge of Child Safety Link and the Atlantic Canada Poison Centre. Some highlights:

- Cannabis products are notably more prevalent in households with younger children aged 0-9 (56-59%) compared to those with older children aged 10-17 (30-38%).
- Nearly three-quarters of respondent's store cannabis products in a locked or child-resistant container
 - There is a significant gender difference: 44% of men leave cannabis products accessible to children compared to 22% of women.
- Nearly 60% of parents are cannabis users, with most consuming by smoking, vaporizing, or eating edibles.

AST Partnership

CSL worked in collaboration with the Active & Safe Transportation (AST) Partnership in Halifax, NS and was involved in a School Streets project that was being piloted. The project was designed to address traffic congestion in schools and promote active transportation by temporary restricting vehicular traffic.









Child Passenger Safety (CPS)

CPS Week (CPSW)

Theme: Right Seat, Right Time, Every Ride

CSL celebrated Child Passenger Safety Week (CPSW) from September 15 - 21, 2024 with many promotional activities including:

- Obtaining Provincial proclamations from:
 - Nova Scotia: Proclamation received from Premier Tim Houston
 - PEI: Proclamation received from Minister of Health & Wellness, Mark McLane
 - Newfoundland & Labrador: Proclamation received from Minister of Digital Government & Services, Elvis Loveless
- Distributing a poster displaying The Right Seat resource that is available in 14 languages to 140 organizations in Atlantic Canada (Nova Scotia: 56; New Brunswick: 38; PEI: 9; Newfoundland and Labrador: 37)
- Implementing a social media campaign that included five reels posted throughout the week. Reels were viewed more than 5000 times between Sept 15 and Sept 30.
- Conducting a Child Passenger Safety Week webinar

CSL measured a 40% increase in website traffic for that week.

Partners: Transport Canada and local RCMP NS also promoted Child Safety Link's theme.

Child Passenger Safety (CPS)

Research

Child Passenger Safety Research Project in collaboration with Dalhousie University.

Roadside checks were held from May-November 2024 to check car seats/errors with RCMP/police and other partners across Nova Scotia.

Purpose:

- Observe and document how children and youth under age 14 years are buckled in Nova Scotia.
- Educate on correct car seat, booster seat and seat belt use.
- Help make corrections to use and installation.
- Ensure all children observed meet legal minimums on departure.



Car Seat Grant Program

CSL implemented a car seat grant program across Nova Scotia providing 22 \$1000 grants. According to the post grant survey, 95% grant recipients found the grant process straightforward and easy to understand.



INSTRUCTOR HUB

CSL established an Instructor Hub with the aim to support and sustain instructors throughout Atlantic Canada to provide technician training and education in communities. With financial support from the Insurance Bureau of Canada, CSL trained and supported **6 new Instructors and 7 current Instructors** with an Instructor toolkit including educational resources, and consultative support. Kits included a choice of supplies that an instructor may need when conducting a course (e.g. sandwich board sign, clip boards, teaching dolls, and a LATCH manual). CSL provides on-going support through consultations, newsletters, and posting on the Community of Practice.

These Instructors have conducted **6 Child Passenger Safety Technician training course** training 43 new CPST. New technicians include Family Resource Centre staff, NS RCMP officers, Fire services, and Tobique First Nation community members). We want to thank them for their commitment to child passenger safety and for helping increase capacity across Atlantic Canada.

Other Support

CSL supports the transportation of children with special healthcare needs and also trains nurses at both IWK Health and NS Health to support safe transportation policies. Although there were no STAC trainings (Safe Travel for All Children) this year, a CSL staff renewed her Instructor status for another three years. A story about CSL and STAC was posted in the IWK newsletter (see below).

CSL also provides orientation about child passenger safety and applicable policies to both IWK and Nova Scotia Health Nurses throughout Nova Scotia. Those who transport children for their work have also been supported with free access to an on-line child passenger safety basics course.

To support newcomer families, CSL implemented a Newcomer Prenatal Car Seat Project (See spotlight on page 22) and also provided 18 additional seats to families in exceptional circumstances at the IWK.



Community of Practice

CSL's On-line Community of Practice (COP) was established in November 2022 and membership continues to grow. The purpose of the COP is to encourage networking and the promotion of injury prevention initiatives. In 2024-2025, CSL extended the COP to include an Atlantic Collaborative on Injury Prevention (ACIP) forum.

IWK Survey


CSL conducted an awareness survey with IWK staff in January 2025. A full report is available. The results will inform the development of an internal communication strategy. Some highlights (n=160 respondents)

- 77% were aware of CSL
- 66% indicated that injury prevention is part of their role
- 48% were aware that CSL offers resources in diverse languages
- 3.75% are members of CSL's COP

Advocacy

CSL supported several advocacy opportunities - for example:

- CSL collaborated on a letter to the Nova Scotia Provincial government to advocated against Alcohol vending machines which could lead to increased risk of injuries in Nova Scotia.
- CSL wrote a letter to the Federal government to support the development of a national strategy to prevent brain injury (i.e. Bill C-277).







Spotlight

Support to Newcomer Families

One of CSL's Strategic goals is: *Advancing equity and inclusivity in the context of child and youth injury prevention.* Below is a spotlight on our work to support newcomer families. This does not include our list of new educational resources (see page 19), poison prevention supplies, and grant programs.

Seats to Families

CSL received a grant from the NS Department of Labour, Skills and Immigration and provided 30 car seats to families receiving care at a newcomer Prenatal clinic at the IWK. CSL also received a grant from the IWK Special Request funding to provide 18 seats for families in exceptional circumstances to facilitate safe discharge of a child where no safe seat was available (55% were newcomer families).

Needs Assessment

CSL conducted a *Newcomers' Needs Assessment Survey to* understand the injury prevention needs of newcomer agencies in Atlantic Canada. Participation rate was 67.67% [67/99 invited organizations participated in the survey]. Some highlights:

- Ukrainian was identified as a high-demand language. Other most requested languages included Arabic, Spanish, Hindi, Punjabi, Mandarin and Tagalog.
- Newcomers in Atlantic Canada inquired most often about child passenger safety, home safety, sleep safety, and poison prevention.
- 81% of participants identified a lack of awareness about injury prevention among newcomers as the most significant barrier.



Equity & Belonging Lens

Equity and Belonging Lens toolkit: CSL adapted the IWK lens toolkit to be more applicable to health promotion/ injury prevention.

Newcomer Event

On November 20 (CSL's birthday), CSL held a launch event at the Immigrant Settlement Association of Nova Scotia (ISANS) and the Refugee clinic. Twenty-two families attend the event. CSL checked 12 seats and gave away six seats. Languages spoken by families: Arabic, Tigrinya, Hindi, Nepalese, Somali.

Support to Newcomers

Educational Resources

As outlined on page 19, CSL develops new educational resources every year and is committed to translating these resources into multiple languages to increase accessibility.

CSL's most robust collection is the Right Seat Resource that is available in 14 languages and is in both print and video (on the CSL YouTube channel).













Media/Social Media

CSL conducts traditional and social media and is developing more media in additional languages. For example, the IWK Emergency Department approached CSL after noticing an increase in burns among specific populations. In response, CSL created a series of social media posts in three additional languages to promote burn prevention.





CSL Team received the IWK STARS Award for Equity & Belonging

The Award honours the spirit of an inclusive, hospitable culture where differences are celebrated, respect is demonstrated, and systemic approaches are challenged and improved.
